Report on a proposal to change the admission arrangements- catchment area of Downham Market Academy effective from 1 September 2026.

The Proposals

This report considers the consultation undertaken by Eastern Learning Alliance for Downham Market Academy in conjunction with Norfolk County Council.

A joint proposal was initiated in response to the recent annual admission rounds. There have been significant issues for children living within the catchment area of Downham Market Academy not being offered places at their local school. This has been particularly evident for those living in the areas furthest from the Academy.

Where preference is not met, the Local Authority has a duty to offer a school place and children are offered places at the nearest school with a place available; as a rural locality, alternatives have been some distance from home addresses involving home to school transport in most cases.

With the uncertainty for families, Local Authority Officers have looked at options, working with Academy Trusts in the area to seek alternative admission arrangements and there the Local Authority in collaboration with the three trusts propose to change the catchment area of Downham Market Academy to:

- Respond to changes in pupil population and balance enrolment across neighbouring secondary schools, ensuring schools are not over or under-subscribed; optimising facilities and resources which support better learning environments.
- Reduce the distance that pupils need to travel to their local school, supporting reduction in carbon footprint and encouraging community and parental engagement.

The following changes were proposed by each academy:

Downham Market Academy

The catchment area for Downham Market High School will be reduced. Watlington Community Primary School and, Upwell Academy are currently feeder schools to Downham Market Academy, under the proposal:

- The Watlington catchment will be reallocated to join the catchment of King's Lynn Academy.
- The parishes of Upwell and Outwell will be reallocated to Marshland High School.
- There will be no change to the Planned Admissions Number (PAN).

Marshland High School

The catchment area for Marshland High School will be expanded to include the parishes of Upwell and Outwell.

There will be no change to PAN.

King's Lynn Academy

The catchment area for King's Lynn Academy will be expanded to include the catchment area of feeder school Watlington Community Primary School.

There will be no change to the PAN.

The changes are proposed to come into effect from 1 September 2026 for the 2026/2027 admissions, without affecting current students.

The Consultation

The consultation ran from 29 November 2024 for six weeks in term time until 17 January 2025

The documents were shared by email, school websites and available as hard copies. Online consultations were also carried out (copies can be located in Appendix A).

Consultation documents were sent to;

- Parents and pupils at the academy
- The governors and staff at Academy
- The feeder primary schools
- Schools in the school cluster groups
- Diocesan Boards of Education
- Trade Unions who represent staff at the schools
- Local Members of Parliament
- Local County Councillors, District Councillors and Parish Councillors

Respondents were invited to share their views in the following ways:

- Completing an online survey
- Completing the form attached to the consultation document
- Emailing the school consultation email address
- Writing to the school office

Summary Analysis

The full analysis is available in Appendix B.

Overall, there were 65 responses to the consultations. The response rate is low.

- 18 people strongly agreed or agreed (28%)
- 4 people neither agreed or disagreed (6%)
- 43 people strongly disagreed or disagreed with the proposal (66%).

Key comments and concerns raised were:

- Siblings will be separated if they attend two different secondary schools
- Travel to KLA from Watlington will take longer than to DMA
- DMA has a real limit in its current capacity and a review is therefore long overdue.
- Additional building in the area is going to impact school admissions and a review is therefore long overdue.

Conclusion

Norfolk County Council has a duty to ensure sufficient school places, this entails working in collaboration with Eastern Learning Alliance. Eastern Learning Alliance is the admissions authority

for Downham Market Academy. Together working with the local authority, we periodically review catchment areas together to ensure they meet the needs of the wider area.

There is significant challenge for pupils in the current Downham Market area not being offered placement at their local school.

The proposed catchment adjustments will ensure that there is sufficient capacity and choice for pupils living in the areas and balances enrolment across neighbouring secondary schools, ensuring schools are not over or under-subscribed; optimising facilities and resources which support better learning environments. This will also reduce the need for pupils to travel longer distances to school.

Response rates to the consultation were low.

The main areas of concern raised during the consultation relate to:

For example:

Traffic and travel concerns to the schools and

Practical challenges to families where siblings attend multiple settings in the area.

These concerns can be addressed by:

- Transport will be provided by the local authority for all students impacted by this change to ensure they are able to get to and from school.
- Students applying for a place living outside of catchment but with a student attending DMA being offered a place to the school immediately after those students living in catchment

The proposals are not anticipated to affect current pupils attending the three schools. Changes would be effective for admissions for the school year 2026/27.

Recommendation

In balancing the responses and comments received during the consultation it will be proposed to the Local Governing Body and Trustees of Eastern Learning Alliance to **agree** that from 1 September 2026, the catchment changes for Downham Market Academy should come into effect.

This action will support the improved distribution of pupils across secondary schools in the area, enabling more pupils to access placements closer to their home address and reducing travel times.

Our proposal

Eastern Learning Alliance in conjunction with Norfolk County Council are proposing to change the admissions arrangements by altering the catchment area of Downham Market Academy, effective from September 2026.

In addition to this change Eastern Learning Alliance is also proposing to change their over-subscription criteria and process in year applications by the school. Further updates have been made to the policy in line with the admissions code.

Why are we consulting on a change of catchment area?

You will have received this consultation as you are a stakeholder and may be affected directly or indirectly by the change. We would like to seek your views on the proposal as part of our ongoing commitment to collaboration and transparency.

Eastern Learning Alliance is the Admissions Authority for Downham Market Academy, however Eastern Learning Alliance and the Local Authority, Norfolk County Council periodically review catchment areas to ensure they meet the needs of the area.

Through the recent annual admission rounds, there have been significant issues for children living within the catchment area of Downham Market Academy not being offered places at their local school. This has been particularly evident for those living in the areas furthest from the Academy.

Where preference is not met, the Local Authority has a duty to offer a school place and children are offered places at the nearest school with a place available; as a rural locality, alternatives have been some distance from home addresses involving home to school transport in most cases.

With the uncertainty for families, Local Authority Officers have looked at options, working with Academy Trusts in the area to seek alternative admission arrangements and therefore Eastern Learning Alliance proposes to change the catchment area of Downham Market Academy to:

- Respond to changes in pupil population and balance enrolment across neighbouring secondary schools, ensuring schools are not over or under-subscribed; optimising facilities and resources which support better learning environments.
- Reduce the distance that pupils need to travel to their local school, supporting reduction in carbon footprint and encouraging community and parental engagement.

This consultation is linked to proposals from Marshland High School, part of West Norfolk Academies Trust and King's Lynn Academy, part of Eastern Multi-Academy Trust.

It is proposed that these plans will come into effect from September 2026, so pupils applying for places from September 2025 for a September 2026 start will be under the new admissions arrangements.

The changes will not affect pupils already attending the school.

Full details of linked proposals can be found on these links; Marshland High School and King's Lynn Academy.

This consultation is in line with the School Admissions Code 2021.

What is a catchment area

A catchment area is a defined geographical area that serves a particular school. In most cases, the area is used to provide priority for admission to a particular school. In planning the layout of a catchment area, the Admissions Authority, in this case Eastern Learning Alliance, should try to ensure that the parent would have reasonable expectation for priority to that school.

What are the proposed changes to the catchment area

The proposal is to change the catchment in the following way:

Downham Market Academy

The catchment area for Downham Market High School will be reduced. Watlington Community Primary School and Upwell Academy are currently feeder schools to Downham Market Academy, under the proposal:

- The parish of Watlington (the catchment of Watlington Community Primary School) will be reallocated to join the catchment of King's Lynn Academy.
- The parishes of Upwell and Outwell plus part of Welney parish (north west of the Old Bedford River/Hundred Foot washes) will be reallocated to Marshland High School.
- There will be no change to the Planned Admissions Number (PAN).


Other changes proposed to the Admissions Policy

A proposed change to the over subscription criteria has been made. This is line with the Eastern Learning Alliance Trust wide staff well-being and retention approach, with the reallocation of working for the school so it is higher up the criteria list.


Other changes made ensure compliance with the latest version of the schools admission code.

Admission Authorities must ensure that their arrangements will not disadvantage unfairly, either directly or indirectly, a child from a particular social or racial group.

Proposed over-subscription Criteria for Downham Market Academy

- 1 Children with an Education, Health & Care Plan (EHCP) that names the school will be admitted. Those children with an Education, Health & Care Plan that does not name the school will be referred to the relevant EHCP Coordinator to determine an appropriate place.
- 2 Any remaining places will be allocated according to the following criteria, in order of priority:

- i) Children in Care, also known as Looked After Children (LAC), and children who were looked after but ceased to be so by reason of adoption, a resident order or a special guardianship order. Children who appear to the Admission Authority to have been in state care (i.e. in the care of or accommodated by a public authority, religious organisation or any other provider whose sole/main purpose is to benefit society) outside of England but ceased to be so as a result of being adopted only.
- ii) Children of staff who have been employed at the Academy for at least two years at the time of application or have been recruited to fill a vacant post for which there is a demonstrable skill shortage.
- iii) Children who live in catchment area, attend **feeder** primary schools within the catchment area and who have a sibling at the school at the time of admission.
- iv) Children who live in the catchment area with a sibling at the school at the time of the admission.
- v) Children who live in the catchment area who attend the **feeder** primary schools within it.
- vi) Children who live in the catchment area
- vii) Children who live outside the catchment area, who attend **feeder** primary schools within it and who have a sibling at the school at the time of admission.
- viii) Children who live outside the catchment area who have a sibling at the school at the time of admission
- viii) Children who live outside the catchment area who attend **feeder** primary schools within the catchment area
- ix) Children who live outside the catchment area, but nearest the school as measured by a straight line

How can I have my say?

Consultation on changes to admissions arrangements are required to be open for a period of six weeks in term time, therefore the consultation will run from 20 November 2024 to 17 January 2025.

What happens next

After this consultation ends on 17 January 2025, Eastern Learning Alliance in collaboration with Norfolk County Council will review the results of the consultation. After considering the findings alongside the consultations linked with Marshland High School and King's Lynn Academy, the Executive Director of Children's Services, will recommend to Eastern Learning Alliance whether to change the catchment area of Downham Market Academy.

The outcome of the consultation will be made public by 28 February 2025 in a determination notice on the school website.

An already oversubscribed school with 2 new estates being built in the town - this is a local authority issue which needs to be rectified by expanding the school - the school has plenty of room for some redevelopment.

There has been recent development in the school to accommodate increased student numbers over several years. Further expansion of the school would require significant financial investment from the Local Authority.

Having one child already attending Downham Academy this suggestion would cause a conflict if the second child were to attend King's Lynn Academy. Due to work commitments/travelling we are able to cover collection from Downham if required (currently a late bus is in use) but not King's Lynn so the second child would be unable to attend after school activities at King's Lynn academy thus having the potential of affecting their educational well being, social development and causing conflict within the family unit. Time between the two schools would be around 30 minutes (not allowing for King's Lynn traffic) with another 15 - 20 minutes to return home form king's Lynn if required to pick up both children.

Eastern Learning Alliance state that they wish to reduce their carbon footprint yet changing the intake from Downham to King's Lynn would increase travel distance and time as well as increasing the number of buses going through the village. These factors would have a negative impact on their carbon footprint.

There is also the matter of working around different school calendars and start/finish times which could impact on child care and also both children's extra-curricula activities.

The second child has also expressed stated that they are looking forward to going to Downham as they have already visited the site, due to the first child, and are familiar with it.

Looking at your map for catchment area it is clear that you are discriminating against Watlington for being a larger school whilst simultaneously cutting other villages in half. See comments above,
